Introduction

This document has been prepared by the NSW Rural Fire Service (NSW RFS). It provides the following Table of Certifying Authorities and Applicable Land to support Clause 1.9 of the *Bush Fire Environmental Assessment Code*.

Bush fire hazard reduction certificates by certifying authorities

A certifying authority may issue a certificate under section 100G of the *Rural Fires Act 1997* for bush fire hazard reduction work on land as described in the Table below.
